

TOWN OF DAUPHIN ISLAND

ORDINANCE NO. 48

AN ORDINANCE TO PROVIDE FOR CERTAIN USER AND  
TRANSPORTATION FEE AND THE COLLECTION THEREOF BY  
DAUPHIN ISLAND FIRE AND RESCUE SQUAD

BE IT ORDAINED by the Town Council of the Town of Dauphin  
Island, Alabama, as follows:

Section 1: Findings by the Town Council of the Town of  
Dauphin Island:

(1) That the Town of Dauphin Island has heretofore  
contracted with the Dauphin Island Water, Sewer and Fire Protection  
Authority for the transfer of the "Fire" portion to the Town of  
Dauphin Island for operation.

(2) That the Town of Dauphin Island does in fact have title  
to all of the personal and real property including equipment and  
fire house, etc. used by the Dauphin Island Fire and Rescue Squad.

(3) That the Dauphin Island Fire and Rescue Squad is  
composed of volunteers and raises funds through its own efforts as  
well as receiving funds from the Town of Dauphin Island pursuant to  
the terms of a contract with Dauphin Island Water, Sewer and Fire  
Protection Authority, collected through a property assessment.

(4) That the Dauphin Island Fire and Rescue Squad wishes to  
collect certain user fees and transport charges from patients and  
victims to augment the over stressed budget of said Squad and in  
accordance with practices in other such squads.

Section 2: The Dauphin Island Fire Department and the Dauphin  
Island Fire and Rescue Squad is hereby granted authority to adopt  
rules and policies for the imposition of reasonable user fees and  
transportation charges for services rendered and to provide for the  
collection and accounting therefor.

Section 3: The Dauphin Island Fire Department and the Dauphin  
Island Fire and Rescue Squad shall make a monthly report of the  
charges and collections to the Town Clerk of the Town of Dauphin  
Island who shall distribute copies thereof to the Mayor and Members  
of the Town Council.

Section 4: The user and transportation fees that may be  
authorized hereunder shall be administered on a fair and impartial  
basis by the Dauphin Island Fire and Rescue Squad.

Section 5: The Dauphin Island Fire and Rescue Squad shall  
submit to the Town Council of the Town of Dauphin Island for  
ratification all policies and rules adopted by the authority  
hereunder.

This Ordinance shall become effective upon its adoption and publication.
